# 15-PASSENGER VAN DRIVER IMPROVEMENT COURSE PRODUCT LICENSE AGREEMENT

### 1. NOTICE. PLEASE READ THIS LICENSE AGREEMENT CAREFULLY.

- 1.1. CENTRAL WASHINGTON UNIVERSITY AND THE WORKSAFE INSTITUTE OF WASHINGTON ARE WILLING TO LICENSE THE MULTIMEDIA CD-ROM PRODUCT TITLED "15 PASSENGER VAN DRIVER IMPROVEMENT COURSE" ("MULTIMEDIA PRODUCT") AND ALL ACCOMPANYING DOCUMENTATION TO YOU ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS CONTAINED IN THIS LICENSE AGREEMENT. PLEASE READ THIS LICENSE AGREEMENT CAREFULLY BEFORE COMPLETING AND SUBMITTING THIS ORDER FORM. BY COMPLETING AND SUBMITTING THIS ORDER FORM YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS CENTRAL WASHINGTON UNIVERSITY AND THE WORKSAFE INSTITUTE OF WASHINGTON ARE UNWILLING TO LICENSE THE MULTIMEDIA PRODUCT TO YOU, AND YOU SHOULD NOT COMPLETE AND SUBMIT THIS ORDER FORM.
- 1.2. The Multimedia Product contains two CD-ROMs, each with different terms and restrictions. The student disk contains an auto-playing, narrated version of the 15 Passenger Van Driver Improvement Course application intended for self-paced, computer-based individual instruction and assessment ("Student Disk"). The instructor disk contains a non-narrated PowerPoint® version of the 15 Passenger Van Driver Improvement Course, assessment questions, answer key, practical driving evaluation form, certificate template and other documentation ("Instructor Disk").
- 2. OWNERSHIP AND LICENSE. This is a license agreement and NOT an agreement for sale. The Multimedia Product, including any text, data, music, sound recordings, images, photographs, animations, motion pictures, and other video incorporated in the Multimedia Product, is owned by Central Washington University, and is protected by U.S. and international copyright laws. Your rights to use the Multimedia Product are specified in this Agreement, and we retain all rights not expressly granted to you in this Agreement.

## 3. GRANT OF LICENSE.

- 3.1. Student Disk: This license agreement permits you to use the Multimedia Product Student Disk on ONE computer at a time. If you conduct driver training concurrently using the Student Disk on more than one computer or at more than one location, you will need to purchase additional licenses. You are NOT permitted to make copies of the Student Disk. NO PART OF THIS CD-ROM OR SOFTWARE MAY BE REPRODUCED, STORED IN A RETRIEVAL SYSTEM, OR TRANSMITTED IN ANY FORM OR BY ANY MEANS, ELECTRONIC, MECHANICAL, PHOTOCOPYING, RECORDING, OR OTHERWISE, WITHOUT THE PRIOR WRITTEN PERMISSION OF THE WORKSAFE INSTITUTE OF WASHINGTON OR CENTRAL WASHINGTON UNIVERSITY.
- 3.2. Instructor Disk: The files on the Instructor Disk are intended to be used by an instructor teaching in a group setting and may be customized and reproduced to suit the needs of your organization. This license agreement permits you to copy, customize or print the materials on the Instructor Disk for the purpose of training your own employees, volunteers or organizational members. You shall have the right to incorporate and customize the files contained on the Instructor Disk, e.g. the non-narrated PowerPoint® version of the 15 Passenger Van Driver Improvement Course, assessment questions, answer key, practical driving evaluation form, certificate and other documentation, in a reasonable manner to produce your own desired training materials, i.e., to create derivative works. However, in all such derivative works, you will prominently acknowledge Central Washington University as author of the original Multimedia Product with the following copyright notice:

- **3.3.** This license does NOT authorize you to copy any portion of the Multimedia Product to the Internet or to a Local Area Network ("LAN"), or any other network. Use or transmission of the contents of either the Student Disk or Instructor Disk over a LAN, the Internet, or any other network, or by any third party is strictly forbidden.
- **4. TRANSFER AND OTHER RESTRICTIONS.** You may not rent, lend, lease or otherwise transfer the Multimedia Product or the license to use the Multimedia Product granted herein to any third party. You may not sell, rent, lease derivative works.
- **5. WARRANTY. Multimedia Product.** The Multimedia Product in this package will materially conform to the documentation that accompanies it. If the Multimedia Product fails to operate in accordance with this warranty, you may, as your sole and exclusive remedy, return the Multimedia Product and the documentation to us from whom you acquired it, along with a dated proof of

purchase, specifying the problem, and we will provide you with a new disc containing the Multimedia Product or a full refund at our election.

WARRANTY DISCLAIMER. WE DO NOT WARRANT THAT THE MULTIMEDIA PRODUCT WILL MEET YOUR REQUIREMENTS OR THAT ITS OPERATION WILL BE UNINTERRUPTED OR ERROR-FREE. WE EXCLUDE AND EXPRESSLY DISCLAIM ALL EXPRESS AND IMPLIED WARRANTIES NOT STATED HEREIN, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
